Subject: CBSE Examination 2022-regarding Invigilation & Evaluation duties during Summer Vacation 2022.

Reference: F.01/AIKVTA HQ/GS/E/2022-24/10, Date 26-04-2022

Esteemed Madam,

Apropos the aforesaid subject and reference, AIKVTA have received so many representations & telephonic calls regarding CBSE Examination-Invigilation & Evaluation duties during Summer Vacations 2022. In this regards maximum Principals of Kendriya Vidyalayas in the whole country yet not finalized any clear directions for teachers.

Madam, Kendriya Vidyalaya Sangathan HQ New Delhi issued a letter on 25.03.2022 that clearly mentioned in the Note points from C to E that Principals of Kendriya Vidyalayas have been instructed to grant proportionate leave (EL/CCL) as is applicable under the rule to the entitled teachers/employees who will be retained at the station for CBSE examination related work (Invigilation and Evaluation) during the summer vacations.

But, some Principals are not following the directions of the **Competent Authority of KVS HQ**, they make self-design rules that CBSE paying remuneration for invigilation & evaluation work so no CCL & EL will be granted.

Some Principals are verbally saying to teachers that they will not leave the HQ up to 15 June 2022 and when their services are required they may be called, some are saying that as and when you will be called for CBSE work you will be entitled CCL in lieu of that day only.

Madam, in the NE & West Bengal without making any plan, Principals is forcing the teachers to stay up to 15th June 2022. Last year in 2021 teachers were also not availed the summer vacations due to preparation for Class X CBSE examination result work.

On the behalf of AIKVTA, I request you to kindly direct all the Principals to prepare a required plan in such a manner that they facilitate the summer vacations for at least 15-20 days for every teacher.

Therefore, **AIKVTA requests your kind** office to give a clear cut instruction to the authority concerned so that no doubt or suspense could be in the mind of teachers related to their legitimate right of EL and they could perform their duties whole heartedly.

Subject: Request to issue a circular for DCs to instruct the principals of their regions-reg.

Esteemed Madam,

Apropos the aforesaid subject, it is requested to issue a circular through DCs to the principals to make roaster of teachers for the CBSE Exams and Evaluation in such a manner so that each & every teacher could enjoy summer vacations not completely at least partially.

Moreover, it must be strictly instructed the principals by the competent authority to ensure their right of leave -CCL/EL for the entire period of stay on the station so that teachers could not face any problem for their EL to be credited in the service books or correspond for the same to the higher authority. It should be circulated on priority basis and done by the principals judiciously.

Madam, a meeting held on 4th March 2022 in your chamber regarding the same issue of Earned Leave (EL) for the teachers who were forced to stay on the station for the preparation of CBSE class X result & other purposes, was discussed at length. Moreover, more than 100 representations were still pending till date. It's an unfortunate situation.
