The Central Executive Committee (CEC) meeting of AIKVTA was held on 11.09.2021 via webinar. During the CEC meeting, you joined the meeting at 9.44 am and shouted and disturbed the meeting by using abusive language & also showed your slap & slipper to all CEC members attached as Annexure – A (copy enclosed). All CEC members opposed your behaviour as you were continuously threatening the CEC members. Mr B P Mishra Regional President of AIKVTA Mumbai Region proposed to suspend you immediately and all The CEC members have agreed to it & approved the same decision by the majority of votes, the output of Google Form where the voting were taken is also attached below as Annexure – B (copy enclosed).

Hence, as per the decision taken by the members of the CEC of AIKVTA you are suspended with immediate effect from the primary membership of AIKVTA, for a period not extending more than six months on the prima-facie charges of Anti-Associational activities, defamation and indiscipline as per Article 5(c) of Memorandum of Association.






