महोदया,

उपर्युक्त विषय के क्रम में निवेदन है कि अखिल भारतीय केन्द्रीय विद्यालय शिक्षक संघ को देश कि विभिन्न केन्द्रीय विद्यालयों के शिक्षकों से लगातार विभागीय प्रतियोगियात्मक परीक्षा-2018 का रिजर्व पैनल जारी करने के संबन्ध में सूचनाएँ प्राप्त हो रही हैं उक्त संबन्ध में बहुत से शिक्षकों का फ्रील्ड वेरीफिकेशन भी हो गया था परन्तु आज तक शिक्षकों पदस्थापन नहीं मिल पाया है।

केन्द्रीय विद्यालय संगठन के द्वारा सीमित विभागीय परीक्षा -2018 का आयोजन जुलाई 2018 में किया गया था संघ ने लगातार उक्त परीक्षा की विसंगतियों की तरफ संगठन का ध्यान आकर्षित कराया परन्तु अभी भी विसंगतियां दूर नहीं हो पाई है अभी भी ऐसे शिक्षक मौजूद हैं जिन्हें ऐसे स्थानों पर पदस्थापन दे दिया गया जहाँ पर पद रिक्त नहीं थे परन्तु अभी तक उनके पदस्थापन में संशोधित आदेश पारित नहीं किये गये हैं।

केन्द्रीय विद्यालय संगठन से न्याय न मिलने एवं संघ के पत्रों को लगातार नजरंदाज करने ले बाद कुछ शिक्षकों ने न्यायालय का सहारा लिया। हाल ही में केन्द्रीय प्रशासनिक अधिकरण नई दिल्ली (CAT Principal Bench New Delhi) में दायर OA No. 2601/2021 & 2668/2021 पर केन्द्रीय विद्यालय संगठन मुख्यालय नई दिल्ली को उचित निर्णय लेने के लिए आदेशित किया गया है।

अतः आपसे पुनः आग्रह है कि सीमित विभागीय प्रतियोगियात्मक परीक्षा-2018 का रिजर्व पैनल एवं पदस्थापन की विसंगतियों का समाधान करने का श्रम करें जिससे को शिक्षकों को पदोन्नति का लाभ एवं न्याय मिल सके।

## **ORDER (ORAL)**

**Hon'ble Ms. Manjula Das, Chairman:**

The applicant is working as Trained Graduate Teacher (TGT) in the Kendriya Vidyalaya Sangathan (KVS). For promotion to the post of Post Graduate Teacher (PGT), there is a provision of Limited Departmental Competitive Examination (LDCE). One such examination was conducted in the year 2018, wherein the applicant also participated. On 05.02.2019, the respondents issued the select panel including extended panel for all the posts. However, the panel for the post of PGT was not issued and promotion orders were issued directly. It is submitted that out of 72 selected candidates, only 67 joined the post of PGT (Geo), and 5 vacancies remained unfilled due to non-joining of selected candidates, for which the respondents issued a waiting list, including the name of the applicant. According to the applicant, though the verification of certificates etc. was undertaken to fill the remaining vacancies in January 2021, it has not been finalized so far. In this background, the applicant filed the present O.A. seeking a direction to the respondents to expedite the process of finalizing the promotion to the post of PGT (Geo) under the LDCE quota.

2. Mr. Yogesh Sharma, learned counsel for applicant submitted that the applicant made representation dated 23.10.2021 in this behalf to the respondents. However, no action has been taken thereon

so far. It is further submitted by the learned counsel that the applicant would be satisfied if the respondents are directed to consider his representation and pass a reasoned and speaking order thereon, in a time bound manner. Mr. S. Rajappa, learned counsel appearing for the respondents has no objection to the prayer made by the learned counsel for the applicant.

3. We heard Mr. Yogesh Sharma, learned counsel for the applicant and Mr. S. Rajappa, learned counsel appearing for the respondents, at the stage of admission.

4. Accepting the prayer made by the learned counsel for the applicant, we deem it fit and proper to dispose of the O.A., at the admission stage itself, without going into the merits of the case, by directing the respondents to consider the representation dated 11.10.2021 made by the applicant and to pass a reasoned and speaking order thereon, under intimation to the applicant, within a period of three months from the date of receipt of a copy of this order.

There shall be no order as to costs.

#### **MA No. 3285/2021**
